- ▶ Items purchased meet the qualifying specifications.


Step #2: Attach a copy of your receipts

- ▶ Please provide copies of all receipts and/or invoices from product purchases or installations.
- ► Your receipt or invoice must clearly indicate the equipment type, make, model, price and date of purchase or installation.

Step #3: Get your rebate

- ▶ Submit completed application with all required documentation. It is recommended that applications be submitted within 90 days of purchase and/or installation, as funds are limited. Applications received after December 31, 2025 will not be accepted.

Electrification Programs

E-Bikes - Residential

Limit one rebate per residential account. Income eligible rebate applicants must qualify for, and have scheduled an appointment to participate in BWL's Home Energy Visit program or have had the appointment in the last three years. Schedule by calling (800) 573-3503. Rebate up to \$1,500 or the purchase price of the bike. Visit **Ibwl.com/electrification** for more information and measure requirements.

E-bike requirements

- All three levels of e-bike qualify:
 - Class 1: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
 - Class 2: an electrical assisted bicycle equipped with a motor that aids regardless of whether the rider is pedaling but ceases to provide assistance when the bicycle reaches a speed of 20 m.p.h.
 - Class 3: an electrical assisted bicycle equipped with a motor that aids only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 m.p.h.
- E-bike must have a minimum one-year manufacturer warranty.
- Battery must be UL 2849 certified.
- E-bike must have two or three wheels and have operable pedals.
- Motor must be 750 watts or less and not powered by gas.
- No kits or adaptions to existing mountain bikes allowed.

E-Cargo Bike Requirements

- Designed to carry one or more passengers in addition to the rider OR designed to carry heavier or bulkier loads than a traditional bicycle can carry.
- Bike has an extended frame or integrated racking (long tail, long john, Bakfiet or box bike).
- Bike's extended frame has a published cargo load carrying capacity of at least 100 lbs.

Induction Cooktop - Residential

Both standalone cooktops and ranges with built-in induction cooktops are eligible. Rebate is only available for installations in new homes and for replacement of existing natural gas or propane fueled ranges or cooktops. Only valid on purchases of new induction ranges or range cooktops.

Induction Cooking Requirements

Induction cooktop must include no less than three elements.

Electric Forklifts - Commercial

Only commercial accounts are eligible for these measures. Limit two forklifts per account.

Commercial Equipment Requirements

- New items only; no retrofits.
- Must be the first electric forklift purchased by the company OR replacing an existing, fossil fuel powered forklift.
- Forklift lifting capacity must be equal to or greater than 3,000 lbs.

Electric Lawn Equipment - Residential

Rebate is only available for new mowers; reconditioned mowers are not eligible. Rebate may not exceed purchase price. Rebates apply to cordless battery models only. Dual battery models can count the voltage of both batteries. Limit one rebate per item per account.

Residential Equipment Requirements

Riding Lawn Mower - 50V minimum | Push Lawn Mower - 36V minimum | String Trimmer - 40V minimum | Chainsaw - 40V minimum | Leaf Blower - 40V minimum |

Customers must recycle their equipment prior to applying for this rebate. Proof of recycling must be included with this application.

Important Information

- 1. Incomplete applications cannot be processed for payment.
- 2. It is recommended that applications be submitted within **90 days** of purchase, as funds are limited. Applications received after **December 31, 2025** will not be accepted.
- 3. Notification of problems with incomplete applications will be sent via email or U.S. Mail.
- 4. Applicants will be given **60 calendar days** to respond before application is deemed ineligible.
- 5. A rebate check will be mailed to you for qualified products. Please allow 4 to 6 weeks to receive your rebate check from the time your application is received by the Hometown Energy Savers® Program.

Terms and Conditions

This offer is valid only for Lansing Board of Water & Light electric customers for a limited time. Offer is good while funds are available and is on a first-come, first-served basis. It is recommended that applications be submitted within 90 days of purchase, as funds are limited. Applications received after December 31, 2025 will not be accepted.

Register receipt/invoice will be used to verify purchase date and/or installation of qualified equipment. Qualified equipment must be used at the Lansing Board of Water & Light Electric Account Holder Address. Products must be new and operational. Refurbished, used, and open box products are not eligible for rebates. Rebates not applicable to new construction. Offer redeemable by mail, email or fax.



Electric Lawn Tools. Lansing BWL electric customers need to make a qualifying electric lawn tool purchase to receive the rebate. Any customer seeking the recycled tool rebate for a given tool must recycle an existing gas-powered tool of the same type (e.g., mower) and comply with the following. Drain the gas-powered tool of all fluids and bring it to either:

Ask for a Lansing BWL recycling receipt and include it with this application. Residential customers must own the units being recycled. Limit one rebate (tool only or tool plus recycling bonus) for each type of electric tool per year.
